The Breakfast at St. Andrew's serves almost 100 meals daily and is run by a 12-member board of directors. More than 100 volunteers, many from outside the church, donate their time on a regular basis. Every morning from 7:30 to 8:30 a.m., we welcome guests who come for a hot meal and the opportunity to enjoy it in a safe comfortable space. Guests include the young and old. Some are experiencing homelessness or struggling with addiction or mental health challenges, but most are working men and women who are trying to make ends meet. The Breakfast Program started with a simple menu of grits, oatmeal, pastries, juice, coffee and, on occasion, hardboiled eggs. Recently we have been able to expand our menu to include more protein and fresh fruits and vegetables. In addition to our standard offerings, our breakfast guests are now able to enjoy specialty items such as sausage, ham, quiche, scrambled eggs, breakfast sandwiches, pancakes, and fresh fruits including watermelon and pineapple. We continue to look for ways to offer variety and nutrition within the confines of our budget and look forward to offering new menu items for our guests.

Form 990, Part VI, Section A, Line 3 - The Executive Director ("ED") of the Breakfast Program at St Andrew's ("BPSA.") is an employee of St. Andrew's Episcopal Church, leased 100% to BPSA. BPSA compensates St. Andrew's Episcopal Church for the ED's services. This arrangement enables the Executive Director to participate in various employment benefits of the Episcopal Church, that might be unavailable/unaffordable for the BPSA by itself. The Executive Director is hired by, works under the direct supervision of, and serves at the pleasure of, the Board of Directors of BPSA in the work of Executive Director.

Form 990, Part VI, Section A, Line 6 - Per the ByLaws of the Breakfast Program at St. Andrew's, St. Andrew's Episcopal Church is the initial member of the Breakfast Program at St. Andrew's. Other members may be added.

Form 990, Part VI, Section B, Line 11b - All members of the Board of Trustees are sent an electronic copy of Form 990, along with solicitation of comments or questions, three days before it is signed and transmitted to the IRS.

Form 990, Part IX, Line 11g - Bookkeeping, Office Management, and Janitorial Services provided by St. Andrew's Episcopal Church.
